Health Care Coalition Lauds Manchin and Capito's "Legacy Act"

Part 2 Coalition Applauds Bipartisan Senate Bill to Strengthen Addiction Treatment

Washington, DC (September 26, 2017) – The Partnership to Amend 42 CFR Part 2, a coalition of over 35 health care organizations committed to helping the country end the opioid crisis, today issued the following statement in response to the introduction of the bipartisan Protecting Jessica Grubb's Legacy Act, (The Legacy Act), S. 1850, by Senators Joe Manchin (D-WV) and Shelley Moore Capito (R-WV).

“We applaud Senators Manchin and Capito's leadership on the introduction of The Protecting Jessica Grubb's Legacy Act, as it will help ensure that persons with opioid and other substance use disorders receive the safe, effective, integrated health care treatment they need, while strengthening protections of their private records. -- *Rebecca Murow Klein, Chair, Partnership to Amend 42 CFR Part 2 and Director of Government Affairs, Association for Behavioral Health and Wellness*
